City of South Pasadena Red Light Camera Analysis
For calendar month of June 1-30, 2011

Total number of events (camera "violations") 1,671

Breakdown by license tags:

Out-of-state license tags 121 (7.25%)
Company owned license tags* 159 (0.51%)

(Company owned and out of state include 75 rental car companies)

*Company registered vehicles and rental cars are drivers that do business in or near So. Pasadena or are visitors to our area. As a result, So. Pasadena is sending a very negative message to drivers in our City.

There are five (5) red light cameras in South Pasadena (6/10ths of a square mile in total area). All are located on Pasadena Avenue, the single north/south thoroughfare in the City. Following is the number of "violations" recorded at each of the 5 locations during the month of June, 2011.

*This one intersection of Pasadena Ave. and Shore Drive S. has cameras both north and south bound where 447 (26.7%) of the total "violations" were recorded, of which 54 (12%) were issued to residents of Shore Drive S. and Pasadena Isle.

IMPORTANT - Concerning the purported reason for these cameras, so-called "pedestrian safety," on June 1, 2011, in response to my inquiry, the Pinellas County Sheriff's Dept. cited the Dept. of Highway Safety and Driver Vehicle Information Database ("DAVID") for the only period available, January 1, 2004 - May 31, 2011, which states: "According to DAVID, there were 3 pedestrian crashes in South Pasadena. They are as follows:

01/01/2006-S011-148160 - Pasadena Ave/14th Avenue S.; 12/26/2008 - S008-331600 - 1893 S. Shore Drive; 05/02/2011 - 0628760 - Pasadena Ave/Hibiscus Ave."

NOTE: One of these fatalities involved a pedestrian in a motorized scooter and none of them were the result of a red light camera "violation" - or where any of the cameras are currently operating. In addition, it appears that in each case of a "violation" issued none of them involved any vehicle collisions or pedestrian injuries or fatalities. So much for lip service about "safety."
